

MEMORONADUM OF UNDERSTANDING

Sillamae Society for Child Welfare (Reg nr.: 80045175, ESTONIA)

and

Fondazione Mondinsieme del Comune di Reggio Emilia (Reg. nr.: 91153530356, ITALY)

on

"EUROMED Education without borders"

Sillamäe Society for Child Welfare and 10 partners will conduct from **5st of September 2016 to 4th of July 2017 in Estonia and Latvia (September), Sweden (October), Morocco (December), Jordan (March 2017) and Egypt (April 2017)** the Anna Lindh Foundation financed project, **EUROMED Education without borders**. **Project objective** is to encourage creative solutions and advance intercultural education among young people of the Euro-Mediterranean region to increase communication and build trust to motivate young people cross borders to take charge of the development of the Euro-Mediterranean region and recognize the benefits of working together across cultural boundaries as we share common goals and a common future. Project target group is and Young people from partner countries who are active and interested in the Euro-Mediterranean issues and have experience in education, youth work and creativity.

Through the three creative meetings the participants have received new ideas and tools on how to use creativity in addressing societal issues and have participated in developing them further. The methodology has been **comprised together into a concrete form as a toolkit and also uploaded o the electronic web-resource that can be used as an education tool by participant organisations**, but also schools, youth centers etc.

OBJECTIVE

This Memorandum of Understanding (MoU) establishes *Fondazione Mondinsieme del Comune di Reggio Emilia* as an official partner in the project EUROMED Education Without Borders. The purpose of signing of this MoU is to ensure that a variety of expertise across the fields of youth work and intercultural citizenship related issues are represented in the EUROMED Education Without Borders process and to ensure the quality, representativeness and sustainability of the results.

The MoU also outlines mutual commitments of the partnering organisation (**Fondazione Mondinsieme del Comune di Reggio Emilia**) and the EUROME Education Without Borders lead coordinator (**Sillamäe Society for Child Welfare**).

Sillamäe Society for Child Welfare shall:

- Give full access to project results Fondazione Mondinsieme del Comune di Reggio Emilia like the web resource and toolkit.
- Pay other project costs related with accommodation, food, international and local travel, promotion materials and other costs specified in the budget.

Fondazione Mondinsieme del Comune di Reggio Emilia shall:

- Spread information about the EUROMED Education Without Borders project and about its results around own communities and publish the information on your website and send to Sillamäe Society for Child Welfare proof like weblinks etc;
- Find and add official media partner to conduct one or two official radio, TV interviews, and articles in a newspaper about the EUROMED Education Without Borders.
- Participate with two representatives in all the planned project events per the timeline specified between partner and coordinator in Riga, Latvia, Goteborg, Sweden, Assilah, Morocco, Amman, Jordan, Alexandria, Egypt;
- Conduct one local activity – training or seminar – using the toolkit in order to adapt it to the local community and provide coordinator with a report (1-2 pages) following the completion of the activity.
- **Co-fund project in amount 2900 EUR**, which includes 900 eur as a Northern partner coordinator fee/salary for whole project (3 months x 300 eur) and 2000 eur financial contributions for accommodation, food, international and local travel, materials. Of that amount Fondazione Mondinsieme del Comune di Reggio Emilia will transfer to the project lead coordinator's bank account (Account owner: Sillamäe Lastekaitse Ühing, Account number IBAN EE861010552012406004) sum of 2000 EUR by the deadline of 1st of December 2016.
- At the end of the project compile and present to the coordinator financial (invoices and proof of salary payment) and content report (local activities).


